

During the history of the town of Acton, there have been four post offices.

Briefly, the history of these four is as follows:

- 1. Acton (2) post office opened on 29 July 1833 and closed on 6 June 1853.
- 2. North Acton post office opened on 8 February 1851, closed on 14 December 1864, re-opened on 21 February 1867, and closed on 23 July 1873.
- 3. The former Shapleigh Corner post office was renamed on 24 December 1830 as Acton (1) post office. This was renamed on 29 July 1833 as Acton Corner post office, which was renamed on 28 November 1853 as Acton (1) post office. The latter is still operating.
- 4. South Acton post office opened on 2 March 1855, closed on 26 January 1861, reopened on 22 August 1865, and closed on 31 March 1944.

In 1914, there were two post offices in the town of Acton: Acton (1) and South Acton. (source: Post Route Map of the State of Maine 1914)




