Waterville Stamp Club captures MUDPEX cup

The MUDPEX Challenge exhibition for Maine stamp clubs was won by the Waterville Stamp Club this year. This is the third year the challenge has been held in conjunction with the Maine Philatelic Society's annual spring stamp auction and bourse.

Previous winners were the Belfast Stamp Club in 1996 and the Portland Stamp Club in 1997. Congratulations to the members of the Waterville Stamp Club for the fine exhibit they prepared.

Several individuals mentioned that although fewer in number, the exhibits this year seemed to be of high quality, indicating that a lot of time, thought and effort went into preparing them for the show, which was held at the Kennebec Vocational Technical College in Fairfield on April 25.

Presently, the MUDPEX Challenge is open only to Maine stamp clubs. Each club may enter only nine pages, and the entry may be composed in any way the individual club wishes. With a whole year to prepare, it takes little effort to put together a prize-winning entry. If your club has not entered previously, plan on an entry in 1999.

Rick Stambaugh elected to MPS Board of Directors

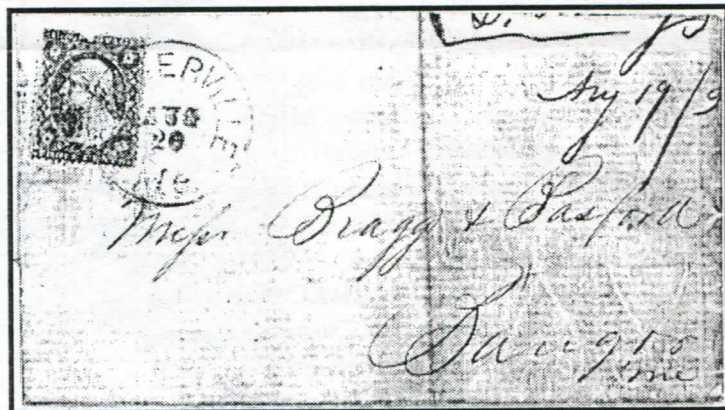
Rick Stambaugh of North Berwick has been elected to the Board of Directors of the Maine Philatelic Society.

Questions arise over cover

The cover illustrated above has a nice copy of U.S. #25 (Scott's Catalogue) and has a clear circular datestamp with SANGERVILLE and AUG 20. The letter is dated August 19, 1858. And there is where the question arises. Sterling T. Dow noted in his landmark book *Maine Postal History and Postmarks* that this post office, located near Guilford in Piscataquis County, was in operation from 1821 to 1857 and closed. It reopened in 1860.

Bruce Hazelton, in *The Post Offices of Maine: A Rarity Guide* notes the office opened on May 7, 1821 in Penobscot County, and after Piscataquis County was created, became a part of the new county on April 30, 1838. He does not show a closing date. Does anyone have additional information about this possible "phantom" post office?

Maine's Air Mail History

The following is a brief chronology of United States Air Mail as it relates to the State of Maine.

FIRST AIR MAIL FLIGHT IN MAINE

Portland to Augusta and return

DATE: October 23, 1919. Postponed from the 22nd because of bad weather.

PILOT: Harry M. Jones of Old Orchard Beach.

AIRCRAFT: Curtiss JN-4C Canuck.

PAYLOAD: One mail bag and pouch. Returning from Augusta, one mail sack with about 300 pieces.

TIME: 47 minutes to Augusta and 56 minutes to Portland.

FIRST AIR MAIL FROM NEW YORK TO MAINE

New York, Framingham, Massachusetts (storm forced landing) to Brunswick, Maine

DATE: June 12, 1922, arrival in Brunswick, 11:11 a.m.

PILOT: Wesley L. Smith, U.S. Air Mail.

AIRCRAFT: de Havilland DH-4 Mail Plane #290.

PAYLOAD: Four pouches and three sacks of mail for Portland, and one pouch for Brunswick.

TIME: One hour and 40 minutes from Framingham.

FIRST AIR PARCEL POST IN MAINE

New York to Portland via Hartford and Boston

DATE: July 30, 1926.

PILOT: B.F. Billings

AIRCRAFT: Fokker Universal N-AABA of Colonial Air Transport.

PAYLOAD: Parcel Post for the Post Office and a shipment of dress goods for the J.R. Libby Co.

TIME: About nine and one-half hours from New York to Portland, including stops.

FIRST SCHEDULED AIR MAIL

Boston, Portland, Rockland, Waterville and Bangor

DATE: August 1, 1931.

PILOT: Captain George W. Snow of Rockport.

AIRCRAFT: Fokker F-10A of Pan American Airways operated for Boston-Maine Airways, 12 passenger Trimotor NC-147H.

PAYLOAD: Thousands of letters each way, most with a special cancellation, plus passengers.

TIME: Boston-Portland, 55 minutes; Portland-Bangor, 90 minutes; Portland-Rockland, 40 minutes.

FIRST SCHEDULED INTERNATIONAL AIR MAIL THROUGH MAINE

Boston, Portland, Bangor, Calais, St. John, New Brunswick, Halifax, Nova Scotia

DATE: August 1, 1931.

PILOT: Captain R.O.D. Sullivan.

AIRCRAFT: Sikorsky S-41 Amphibian of Pan American Airways Co. NC-41V.

PAYLOAD: 9,050 pieces of mail weighing 111 pounds in pouches from Portland included, plus passengers.

TIME: Six hours Boston-Halifax.

BEGINNING OF CONTINUOUS

AIR MAIL SERVICE TO MAINE CITIES

FROM BOSTON AND RETURN

Boston, Portland, Rockland, Waterville and Bangor

DATE: August 11, 1933.

PILOTS: Captains Milton Anderson and Hazen Bean.

AIRCRAFT: Stinson SM-6000's -- 10 passenger Trimotors.

PAYLOAD: Passengers plus air mail.

TIME: Boston-Portland, 50 minutes; Boston-Bangor, two

hours and 15 minutes.

FIRST HELICOPTER AIR MAIL

Portland to Salem, Massachusetts

DATE: October 31, 1946.

PILOT: Not listed.

AIRCRAFT: Sikorsky HNS-1, Coast Guard.

PAYLOAD: Three pouches of mail.

TIME: Helicopter crashed in Massachusetts.

Think you could get away with this today?

In the early days of the 19th century, before the advent of adhesive postage stamps, the Post Office Department was sometimes used involuntarily to settle small debts between correspondents. An example is shown here.

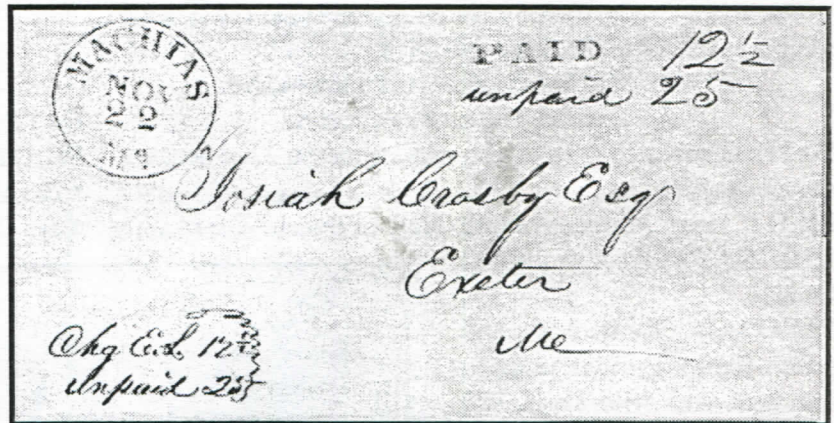
The illustrated letter was sent by Edwin Longfellow, Esq. of Machias to Josiah Crosby, Esq., of Exeter. Both men were lawyers, and following the custom of the time, Mr. Crosby had retained Mr. Longfellow to handle a case for him at court in Machias. Mr. Longfellow had done so, and was in this letter remitting the case settlement monies, as well as associated fees to Mr. Crosby.

The total settlement amount due Mr. Crosby from Mr. Longfellow was \$43.13, and the letter gives the detailed accounting of the charges. In the letter, Mr. Longfellow apparently enclosed \$43.00 in cash, leaving 13 cents still owed, which he could not very well include in the stampless folded letter.

However, the Post Office Department provided a clever way to pay this debt. The total postage due on the letter should be 37.5 cents: 12.5 cents for the single page letter, and 25 cents for the enclosure (the \$43.00). This postal charge, of

course, would be part of the legal fees for the transaction payable by Mr. Crosby to Mr. Longfellow.

To settle the indebtedness of the remaining 13 cents, Mr. Longfellow simply paid 12.5 cents of the postage



charge, leaving a postage due of 25 cents for Mr. Crosby to pay when he received the letter. Thus the Post Office Department in effect served as banker through which a small debt of 13 cents was settled.

I was always a history nut, especially U.S. history. When I found a friend had some U.S. stamps that he wanted to give me, I looked at them and found they were historical and not just a stamp to put on a postcard or letter. I found each stamp

was issued for a purpose, either to commemorate a special someone or something. I learned all I could about each stamp. All this information was at my local library.

Less than five miles from where I live there was a club I could join and learn even more. Wow! I stumbled into a whole new era of my life. I had history, a collectible item and some new friends who could help me learn even more. I was in seventh heaven!

After attending a meeting, I found that stamps were issued in every country. Some countries depend on revenue from them for a major part of their national budget. Soon I was a regular at meetings, even taking my wife and daughter. My daughter is a big Disney fan and she started collecting stamps and mother and daughter started a topical collection of cats. This was a family event for so little money. No longer was I a stamp collector, I was a "philatelist."

At one meeting I was asked if I would be interested in attending a Maine Philatelic Society meeting. I thought, "They even have a Maine society just for us!" I attended and was greeted very warmly by the group. They asked me to join and I was ready to give them my credit card when I learned dues were only \$5 a year. I just paid my fraternal organization dues
