Historic Maine cover comes home; looking for new owner

An interesting Maine cover with strong historical connotations has been donated to the Maine Philatelic Society on condition that it be auctioned to members.

The generous donation is from the Virginia Postal History Society. In a letter accompanying the cover and contents, Renate and Jim Thayer, president and vice president respectively of the Virginia Postal History Society, said they don't remember how the society obtained the cover, "but it's yours now!"

The cover is addressed to the editor of the *Morning Dispatch* in Erie, Pennsylvania, and was postmarked on July 26, 1884 with a Bar Harbor CDS.

The cover and letter inside were written by James G. Blaine, a one-time U.S. presidential candidate and influential politician in the 1800s. Blaine was born in 1830 and died in 1893. He was U.S. Representative from Maine (1863-76); Speaker of the House (1869-75); U.S. Senator (1876-81); U.S. Secre-


tary of State (1881, 1889-92). He was first called the "plumed knight" at the 1876 Republican convention, where improper influence he had used in the case of an Arkansas railroad prevented his nomination.

Nominated in 1884, he was largely defeated for President by "rum, Romanism, and rebellion," an epithet used to characterize Democrats by a New York minister supporting him. As Secretary of State, he fostered closer U.S. - Latin American ties, and brought about the first Pan-American Congress.

In the letter, Blaine talks about the convention, but notes at the top: "Not for publication." There is a strong signature at the bottom. The letter is in excellent condition for being well over a century old. The cover is in good condition as well, somewhat toned by age, and frayed at the top. But this does not affect the stamp or CDS.

Here is your chance to own an excellent piece of Maine postal history. The cover and letter will be awarded to the highest bidder. All bids must be by letter, and be certain to include a mailing address and telephone number. All bids must be received by midnight on March 1, 1999. Please be generous in your bidding as the money will go to the society. And a special thank you to Renate and Jim Thayer and the Virginia Postal History Society!

Postal history of Bridgton, Maine began as early as 1800

Lines of communication as they existed in the days of the early settlers of Bridgton were synonymous with the routes and methods of travel. In brief, the foot traveler and such messages as he might carry were the only contact with civilization that the first pioneers had or expected.

Even the establishment of a post office in Bridgton Centre as long ago as 1800 meant little in respect to mail service. The post office as such was merely an officially designated depository for any letters that might be brought in by horseback or possibly wagon, and the postmaster had the authority and responsibility to dispatch mail by whatever means he could find. He charged for the service, affixed his own indicia to show that "postage" had been charged, and reported to Washington where the Postal Department kept some record

of the quite haphazard system. Not until well into the century did the Post Office Department contract for the carrying of mail between towns, utilizing for the most part such stage lines as existed.

The first local postmaster was Joseph Sears and he undoubtedly diverted some small section of his tavern for the purposes of mail handling. It was the accepted procedure for the postmaster to carry out his limited functions from his home or place of business. He would unquestionably be the principal source of information and willing to share such news as his infrequent patrons might transmit.

Actually, until at least the middle of the 19th century, his duties were not confining enough to prevent him from following a business or profession while also carrying the title of postmaster. By today's standards, the volume of mail must have been inconsequential. It is also probable that his wife or a relative assisted in the post office business.

The late Mrs. Clara Berry of South Bridgton used to relate how her husband's grandfather, Nahum Knapp, a shoemaker, had a large pigeon hole desk where he sorted and held mail before the government postal service was instituted in South Bridgton. Further service depended on the passing through of travelers. South Bridgton had a post office from 1829-1955; Sandy Creek's post office operated from 1879-1927; Bridgton had a post office for the period 1852-1901. Even Berry's Mills, somewhere between Denmark and South Bridgton, had a post office, but now few could locate Berry's Mills let alone its post office!

The North Bridgton post office has been in continuous existence since 1821 and its first postmaster, Nathaniel Howe, also the town treasurer, held the appointment for three years. He had previously served as postmaster at Bridgton from 1818-1821.

Names prominent in other spheres of the history of Bridgton are conspicuous in the lists of postmasters for these several offices. Their terms have coincided generally with the Presidential terms of office, for until 1940 a change in federal administration presaged a change of postmaster. The position now has the protection of Civil Service appointment and a full-time position, as part of the bargain.

Following Mr. Sears, Bridgton's postmasters and their dates of appointment were: Samuel Andrews (Jan. 11, 1809); Nathaniel Howe (Jan. 28, 1818); Richard Davis (Feb. 26, 1821); Nathaniel S. Littlefield (Dec. 29, 1828); Rensellaer Cram (May 1, 1841); Samuel Andrews (Apr. 11, 1845); Clement J. Adams (Feb. 15, 1849); William J. Hayden (Mar. 30, 1853); Thomas Cleaves (June 2, 1856); Samuel M. Hayden (June 23, 1856); Luther Billings (June 22, 1861); S.M. Harmon (May 28, 1869); Charles E. Gibbs (Feb. 14, 1872); Thomas J. Douglas, 2nd, (July 30, 1885); John H. Roes (Jan.

6, 1891); Frank P. Bennett (Jan. 15, 1895); Abel H. Harriman (Mar. 2, 1899); John F. Davis (Jan. 16, 1902); Frank P. Davis (Jan. 12, 1914); Howard W. Janes (Sept. 22, 1922); Perry J. Murphy (April 25, 1927); George M. Oberg (Feb. 28, 1929); Marjory D. Wolley (June 1, 1933); Everett F. Larrabee (Nov. 19, 1940); and Henry A. Shorey (April 4, 1957).

The situation at North Bridgton was much the same in respect to frequent changes in the postmastership. The present incumbent, Hurschel A. Ryerson, who was appointed June 30, 1946, has held office longer than any of his predecessors.

Following Mr. Howe at North Bridgton were Ira Crocker (Feb. 24, 1824); Caleb Stevens (Feb. 6, 1845); John F. Potter (June 29, 1847); Samuel Riggs (July 26, 1861); Albert Gould (Oct. 13, 1873); Hannah C. Proctor (Feb. 16, 1874); Edward Kimball (March 18, 1879); Horace C. Kimball (Feb. 4, 1886); Horace A. Hall (Apr. 10, 1889); Horace C. Kimball (Apr. 1, 1893); Charles W. Hill (June 22, 1897); Charles H. Gould (Nov. 23, 1905); Carrie Wentworth (Oct. 11, 1912); Charles R. Kendall (Oct. 24, 1919); Bessie Kendall (May 12, 1934) and Postmaster Ryerson.

Particularly in the early days, the site of the various town post offices changed about as frequently as the postmaster. Lease arrangements were not a part of the Post Office Department's concern and it was not until toward the last of the previous century that locations were contractually pinned down.

It is significant that at South Bridgton the established post office began and ended its days at the same spot, the old T.B. Knapp country store at the four corners below Minister's Hill. Thomas Knapp was appointed postmaster May 13, 1873 and when the office was officially closed July 1, 1955, Mrs. Erna E. Field was conducting it at the identical location for a population of 48 families.

The first postmaster appointed at South Bridgton was Ashbel Cram, on Jan. 16 1829. Successors and the dates of their appointment were Marshall Cram (Feb. 7, 1840); Jonathan Fessenden (Oct. 15, 1845); Benjamin F. Barker (Aug. 27, 1853); Edward R. Staples (Mar. 7, 1862); Ashbel Chaplin (Aug. 29, 1867); Thomas Knapp (May 13, 1873); Fred N. Berry (Oct. 19, 1895); Thomas B. Knapp (Sept. 22, 1897); Fred W. Sanborn (Oct. 24, 1914); Raymond P. Whitney (June 7, 1918); Clara S. Berry (Oct. 24, 1922); Edith Durfee (Feb. 26, 1927) and Mrs. Field (March 4, 1935).

West Bridgton's post office was established March 31, 1852 with George Small as postmaster. He was followed by Richard D. Douglas on April 22, 1864, and then by Samuel M. Sawyer, Jan. 16, 1867. Orin B. Hibbard who was appointed May 9, 1881 saw his office discontinued briefly from Oct. 10, 1887 to March 21, 1888. The last postmaster for this section of town was William F. Holt who was appointed Oct.

18, 1888. The office was discontinued officially on Sept. 30,

The office for West Bridgton was at one time located at the site of the present Ray Riley residence, just west of the Pleasant Mt. ski area road. Business was carried on during Mr. Holt's tenure at the present home of George Hilton. Orin Hibbard also drove the mail stage while he was postmaster. Later, Joseph Mackie brought in the mail to Mr. Holt's office by way of Brownfield.

The life span of the Sandy Creek post office very nearly coincided with that of the Bridgton and Saco River Railroad. Actually, the office came first but it was logical to maintain such an establishment as long as mail was regularly being transported right to the door. Postmasters and dates of appointment were Theodore E. Lang (Mar. 14, 1879); George W. Harrison (April 26, 1883); Olando V. Plaisted (Sept. 25, 1885); John W. Hubbard (July 17, 1897); Frank A. Stevenson (June 15, 1898); Laforest S. Ingalls (Dec. 19, 1899) and Mary M. Ingalls (Dec. 26, 1914). Mail was received and distributed right at the railway station while Mr. Plaisted was postmaster, but from Mr. Hubbard's appointment until discontinuance of the office, the Sandy Creek general store contained the post office.

On the same date that the South Bridgton office was closed, July 1, 1955, the little office at Hillside was terminated. This was a rather exceptional situation in that during the entire 48 years of its operation, the Hillside P.O. remained in the hands of the Irish family. Howard Irish was appointed as the first postmaster; his wife, Lucy, succeeded him; and a daughter-in-law, Mrs. Helen Irish, closed out the office as its last postmaster. Mail for Hillside was received and dispatched via the Bridgton office, and the mail messenger service also was performed by members of the Irish family.





An example of post office overkill on cover to Norway



The following is a letter I sent to the Portland postmaster in October.

"A few weeks ago, I sent correspondence in a large envelope to a correspondent in Norway. As she is an avid stamp collector, I franked the envelope with a variety of older U.S. postage stamps.

"I have just received a reply from her, and she included a photocopy of the envelope as it arrived at her home. I am enclosing a copy.

"I do not know where the felt marker was used to obliter-



ate the stamps, but it was obviously unnecessary as the envelope had been cancelled. Somewhere, between Portland and Bodo, Norway, a mean-spirited postal worker did his/her best to spoil these stamps for use by a stamp collector.

"I am not, I cannot, accuse a postal worker from any particular location for this malevolent action. I can only express to you the hope that it did not happen in Portland. I am concerned, however, that my correspondent would be more apt to place the blame here rather than on her countrymen.

"However, I do wish that you would remind postal workers that there may be underlying reason why sometimes correspondence is franked with a variety of postage stamps beyond covering the postal fee. You are aware of all the 'bad raps' that are given to the U.S. Postal Service. This is an example of one that can be prevented and that you don't need.

"It happened and I hope 'it' happened in Norway and that 'it' never -- ever-- happens in Maine. Thank you for taking your time to hear my complaint."
