Oddities exist on many Maine postmarks

While looking for Maine postmarks, we sometimes find these with odd spellings, misplaced punctuation, words cut from the cancels and supposedly "unlisted" names. The following are a few examples that have been found.

The word "MAINE" was difficult to spell as found in the following cancellers: CEDAR GROVE, MIANE, four bar, 1912; MIDDLEDAM, MANIE, four bar, 1910; NORTH SEARSMONT, MANIE, four bar, 1913; WESTFIELD, MIANE, four bar, 1911.

Improper placement of punctuation made for interesting variations: ROUND, POND Maine (comma between "Round" and "Pond"), four bar, 1950.

Some postmasters adapted existing cancellers. Christmas was changed to Christmas Cove in 1911 and remained as such until discontinued in 1974. For some reason, the postmaster

removed "Cove" in the mid-1950s and used his unofficial "Christmas" canceller for several years. Hence, the canceller read "CHRISTMAS ---- MAINE" (four bar, 1956-1957).

North Newry was discontinued on June 30, 1953 and the post office was moved to Newry Corner. The new four-bar canceller had not been received by the postmaster, so the "North" was cut out and the same cancel used on the first day of operation on July 1, 1953. A new cancel was placed in use on July 16, 1953. Hence, ---- NEWRY MAINE (four bar, 1953).

The postmaster at Palermo wore out the old four bar canceller and went through two non-standard devices that he put together himself. Nearly 30 years earlier the post office at North Palermo was closed and the rubber canceller was retained at the Palermo Post Office.

So, the postmaster cleaned it up and removed the "North" *Continued on page 4*



The very small cover illustrated on this page was posted in Gardiner, Maine and originally addressed to Dresden. Before it reached the addressee in Cedar Grove, it had received eight more cancels and had been handled in five different post offices (twice in Richmond and West Dresden).

The five post offices were located in three different counties (Kennebec, Lincoln and Sagadahoc). The cover was never more than 10 miles away (Richmond) from the post office where it was posted (Gardiner).

All of the cancels are on a three and a half inch by two and three quarter inch envelope. Two of the cancels are DOANES (Iceboro 2/2 and Cedar Grove 2/3). These two post offices along with Dresden and West Dresden post offices are now DPOs.

The probable routing was thus: posted at Gardiner at 2:20

a.m. on July 19, 1904. From there to Richmond, postmarked at 7:00 a.m. on July 19, 1904. Then to Dresden the same day, but without receiving mark; Richmond, July 20, 1904, 10:00


Early South West Harbor cover has nice target cancel


A letter posted from South West Harbor on August 29, 1883 for delivery to Weldon in southeastern Pennsylvania features a nice target cancel. The reverse side of the envelope has a New York transit postmark dated either August 30 or 31. The stamp (Scott #207) was issued in 1881.

Steamships were the primary source of commerce and transportation for the coastal communities during the nineteenth century. An advertisement from the *Bar Harbor Record* newspaper of 1886 shows regularly scheduled sailings to Rockland, Portland and Boston. Mail dispatched from Southwest Harbor by the 2 p.m. steamship departure time, and traveling by rail from

Boston, Portland or even Rockland could arrive at New York City the following day.




Steamer Mount

a.m.; West Dresden, July 20, 1904 but without receiving mark; Iceboro, July 21, 1904, but without time in the morning; West Dresden, July 21, 1904, but without receiving mark; and finally, Cedar Grove on July 21, 190(4) in the afternoon (exact time of arrival unknown as there is no arrival time in the CDS).

(EDITOR'S NOTE: Mr. Bache-Wiig noted that his interest in Maine postal cancels goes back many years, but he became deeply involved about a decade ago when he began searching for where many of the DPOs had been located. It's arduous work, he said, noting that he was working on his third Maine atlas in a relentless search for places that no longer exist except in memory.)

on a canceller issued about 1907 to another post office. He finally had to order a new canceller when this one wore out. There were none left to make over! ----- PALERMO, MAINE (four bar, 1942).

In an economic move during the late 1950s and early 1960s, the Post Office Department closed many small, fourth-class post offices. Some were reopened as rural stations of the nearest larger post office. One of these was Hodgdon and the new canceller read in error: "HOULTON, MAINE, HOGDDON RURAL STA." (four bar, 1964). A rural station cannot be a station of itself. But that is exactly how the following cancel reads. It should have been "East" and does have the East Lebanon Zip Code -- maybe that's all that matters! "WEST LEBANON RURAL STA. WEST LEBANON, ME 04027" (four bar, 1995).

Finally, where in the world is **SOUTH CABOO**? Most likely in Alaska; it's not listed in Maine as such. A closer look reveals a cancel from SOUTH CASCO with right spacing of the "C" and "S." The openings are filled with dried ink and paper fibers from postmarking letters. At least it makes an interesting postmark: "SOUTH **CABOO**, MAINE" (four bar, 1914).

Some Maine post office names were always one word. Occasionally when new cancellers were ordered, they came back as two words: "DEAD_WATER, MAINE" (four bar, 1926); "MACHIAS_PORT, MAINE" (four bar, 1912); "MEDDY_BEMPS, MAINE" (four bar, 1916). From then on, the cancellers remained one word for these post offices.

It was a different story at Kokadjo. I suspect the postmaster changed the wording in the cancel to go along with the spelling change on the postcards sold at the store. "KOKAD-JO, MAINE" (non-standard double ring four bar, 1917). When the cards were sold out, new cancel and cards were ordered and Kokadjo stayed the same.

What Maine post office had the largest four-bar canceller in the last century (this does not include self-inking cancels)? "HARTLAND, MAINE" (swollen to oval shape 42x39, 22 [1920]); "McKINLEY, MAINE" (swollen to oval shape 35x44, 25 [1954]); "ORRS ISLAND, MAINE" (non-standard double circle 34x23, 21 [1941]).

In 1915, the Post Office Department issued a freeze on all new rubber cancellers. This was due to a rubber shortage brought on by the impending war in Europe. Postmasters with worn cancellers were instructed to use the discontinued SCDS (single circle date stamp), REC'D or the least used DCDS (double circle date stamp) such as C.O.D., M.O.B., PARCEL POST, REGISTERED.

The postmaster had to remove this wording from the cancel before he postmarked any mail. When this altered cancel wore out, the same would be done to another one. The following examples have been seen in Maine and only one postmaster had to go through two cancels before the rubber shortage was over:

ABBOT VILLAGE, MAINE:

"M.O.B." removed, 1915-17, maroon ink, DCDS; ABBOT VILLAGE, MAINE:

"REGISTERED" removed, 1921-22, blue ink, DCDS;

CASCO, MAINE:

"M.O.B." removed, 1921-23, DCDS;

NORTH WATERFORD, MAINE:

"REC'D" removed, 1922, SCDS;

PORTAGE, MAINE:

"REC'D" removed, 1921, SCDS;

YARMOUTHVILLE, MAINE:

"REC'D" removed, 1916, blue ink, SCDS.

New Worcester Plantation was settled by Marines from Massachusetts who had been forced to find other work and a new place to live after the Revolutionary War. They finally decided to name their new town after Orangetown, Maryland. In March of 1788, Parson Noble went to Boston to have the name of the new Maine town registered. He told the clerk that it had been voted to name the town Orangetown.

The clerk filled in the legal forms, but his spelling was not the best. Therefore, Orangetown was written down ORRINGTON. It was not what the town members had requested, but they decided not to change the unique spelling.

On February 28, 1959, the postmaster at South Orrington retired and the post office was closed. But on March 1, 1959, the "South Orrington Rur. Sta., Orrington, Maine" was created for one reason -- "because the ground was frozen." The people who had picked up their mail at South Orrington were now on an RFD route. They would need some spring weather to thaw the ground so that posts and mailboxes could be installed.

The rural station was closed on May 29, 1959 when all posts were installed and mailboxes ready for the RFD service to start. The "South Orrington Rur. Sta." was closed one day early. Postmarks are not common as this rural station was open for only 77 days. It was the shortest one to operate in Maine.


PIONEER POSTCARDS

Flaq Day 1896 Political Postcard



This spectacular 1896 U.S. government postal card takes advantage of Flag Day to promote presidential candidate McKinley and vice president Hobart. Not only does it have eye-catching graphics, but coincidentally it was bought at a New York philatelic show exactly 100 years later to the day on Oct. 31, 1996.

The message printed here from the Republican National Committee was to display the McKinley and Hobart pictures along with the American Flag on Oct. 31, 1896, then Flag Day. Patriotic postcards during the pioneer period are quite rare and this multicolored card is a super example. In case you did not count, there are 45 stars on this flag.





Maine Cover of the Quarter


A postal history feature by Rob Washburn of Skowhegan
