
Easton was originally a township owned by the Commonwealth of Massachusetts, but around 1854, like all the other towns in Maine remaining in the hands of Massachusetts, it was purchased by the State of Maine. It was incorporated in 1865. Previous to that date, it was called Fremont Plantation.

During the history of the town of Easton, there have been three post offices. Briefly, the history of these three is as follows:

1. **Easton** (1) Post Office opened on 7 April 1858, closed on 13 May 1859, re-opened on 8 January 1862, and closed on 29 February 1908.

2. **Manchester** (1) Post Office was established on 15 September 1853; on 16 May 1856, it was renamed **Fremont** Post Office, which closed on 21 July 1869.

3. **Sprague's Mills** Post Office opened on 27 February 1879, was renamed **Spragues Mill** 1893, and on 23 March 1908 was renamed **Easton** (2) Post Office, which is still in operation. What does it mean when there is a (1) or (2) after the name of a post office?



In 1869, there were two post offices in the town of Easton: Easton (1), and Fremont. Sprague's Mill, which did not open until 1879, is also shown on this map. Post Offices in Easton are listed below. In addition, postmarks that collectors have provided from the towns/villages associated with Easton for this project have been included.

29 February 1908:

Easton Post Office closed. Service from Sprague's Mill



The circular postmark is 30 mm in diameter with a nine-bar elliptical duplex killer. 4 December 1923:

Bernard V. Thompson became Acting Postmaster for Easton (2) Post Office.

21 March 1924:

Bernard V. Thompson became Postmaster.



9 May 1932: The circular postmark is 30.5 mm in diameter with a four-bar (B) killer.

31 May 1936:

Marguerite Cahill became Acting Postmaster for Easton (2) Post Office.

25 June 1936:

Marguerite Cahill became Postmaster for Easton (2) Post Office.



The circular postmark is 21 mm in diameter with a six-line wavy machine killer.

28 December 2000:

Pauletta Lockhart became Officer-in-Charge for Easton (2) Post Office.

7 April 2001:

Herman J. Fortin became Postmaster for Easton (2) Post Office.

8 April 2005:

Pauletta L. Lockhart became Officer-in-Charge for Easton (2) Post Office.

20 August 2005:

Pauletta L. Lockhart became Postmaster for Easton (2) Post Office.

27 February 2008:

Sharon J. Crane became Officer-in-Charge for Easton (2) Post Office.

17 September 2008:


20 April 1893: The circular postmark is 27 mm in diameter with a four-circle target killer.

1 July 1893:

Charles W. Spear became Postmaster for Spragues Mill.

7 June 1897:

Melville L. DeWitt became Postmaster for Spragues Mill.



25 May 1901: The circular postmark is 29 mm in diameter with an elliptical duplex killer. A similar postmark and killer dated 4 April 1891 is known.

The circular postmark is 29 mm in diameter with a nine-bar elliptical duplex killer.

21 January 1908: The circular postmark is 32 mm in diameter with an unidentifiable killer.

23 March 1908:

Spragues Mill Post Office is renamed Easton (2) Post Office.

What does it mean when there is a (1) or (2) after the name of a post office?

Sometimes the numbers (1) and (2) appear after the name of a post office. These numbers indicate the (first) and (second) localities of post offices of the same name. For example, if the post office name is used for two separate post offices in two respective villages at different times, they will be identified in this manner. These numbers do not necessarily indicate time periods.

These numbers do not represent numbered stations. Some larger places, like Auburn, have postal stations with numbers. These differ from the post offices we call Auburn (1), Auburn (2), etc.

Also: the numbers do not appear in postmarks or official post office publications. However, they are used by postal historians and collectors to refer to different post offices, as noted above.
